2011 Annual List of Obligation

Federal regulations require MPOs to publish an annual listing of projects for which federal funds have been obligated in the preceding year as a record of project delivery. Although it is the primary responsibility of the MPO to prepare the obligation list, the list must be developed though a cooperative effort with WSDOT and others who are responsible for tracking project obligation. The Term "obligation" is the federal government's legal commitment to pay the Federal Share of a project. Once funds have been obligated, the project sponsor begins incurring eligible project expenses and then will request reimbursement from Federal Highways or Federal Transit. Projects for which funds have been obligated are not necessarily initiated or completed in a single program year, and the amount of the obligation will not necessarily equal the total cost of the project. All projects were listed in the previous year TIP and are consistent with the adopted Metropolitan Transportation Plan. The following is a list of federal transportation projects within the MPO boundary for Southwest Washington Regional Transportation Council (Clark County, Washington) that were obligated during the previous calendar year.
